The Maine CDC's Maine Immunization Program (MIP) announced that ordering for the 2025-2026 COVID-19 vaccine is now open. In alignment with a Health Advisory Notice (HAN) issued September 23, 2025, and the Standing Order issued September 12, 2025, which reflect recommendations from the American Academy of Pediatrics (AAP), the American Academy of Family Physicians (AAFP), and American College of Obstetricians and Gynecologists (ACOG), MIP will supply the

updated COVID-19 vaccine to all children 6 months through 18 years.

# Food Access Resources to Share with Patients and Families during the Government Shutdown

As you may know, the US Department of Agriculture (USDA) has instructed state agencies to pause the distribution of November SNAP and WIC benefits until further notice due to the ongoing federal government shutdown. This lapse is expected to leave tens of millions of people without the food and nutrition benefits they rely on, including the 55,000 Maine children that receive SNAP and 18,500 babies and parents who receive WIC. Without SNAP and WIC benefits, many families will be in desperate need of food assistance.

#### Here's how you can help:

- Connect patients & families with local resources, including food banks/pantries and community kitchens. **Use this food bank locator.**
- Remind families that <u>ALL</u> Maine students are legally entitled to <u>free</u> breakfast and lunch at school.
- If you work in a school, remind families about your school's food cubby or pantry. If your school doesn't have a cubby or pantry yet, consider creating one so that students can take home shelf-stable goods. This can help to take some pressure off food banks that are under strain. Check out these best practices for starting and maintaining a school food panty.
- Screen for food insecurity. Help to de-stigmatize food insecurity and encourage families to seek support. Professional resources here.

# Did you know...

2.5% of children tested for lead in the US have a level greater than or equal to 3.5 ug/dl, though there is no safe level of lead in the body? And, that 30% of Maine homes are built before 1950 - when lead paint was heavily used? All families with young kids can test their homes for dust. Connect your families with a free lead dust kit today whether they have a lead level >3.5 ug/L or not. Lead poisoning can be prevented. Families can sign up for a free home lead dust kit here. If you would like to review data on lead testing and poisoning in the state of Maine or in your county, you can do so on the Maine Tracking Network found here.

Be There for ME Provides Judgement Free Resources for Families Seeking Help including childcare, transportation, housing, food, stress management, and substance abuse.
