President's Message



Webinar Series! Children with Intellectual and Developmental Disabilities that Experienced Trauma

In the US, an estimated one in six children has a developmental disorder, including intellectual disability, autism, and other genetic and brain-based conditions. Children with intellectual and developmental disabilities (IDD) experience traumatic events at a rate that is at least equal to their typically developing peers and are at increased risk for some types of traumatic events, with serious negative impacts. This series will provide clinicians with the foundational knowledge to adapt their practices and provide trauma-informed care to children with IDD.

Campaign to Reduce Tobacco/Nicotine Use among Youth

Tobacco use among Maine youth is on the rise. Maine's high school smoking rates are higher than the national average and the second highest in the Northeast.[i] In 2019, 1 in 3 Maine high school students used some form of tobacco, including cigarettes, smokeless tobacco, cigars, and electronic cigarettes.[ii] That's a 33% increase since 2017!

Let's work together to educate Maine youth on the dangers of smoking and vaping. Provider education to share strategies for youth cessation will be offered this spring.

Join the Maine AAP, along with partners from the Heart, Lung and Cancer Associations and other organizations across the state, on a campaign to provide education and introduce legislation.

There are 3 actions that Maine lawmakers can take this year to give youth and young adults a fair shot at a healthy and productive future, free from addiction, tobacco-related illness, and too often, early death:

1. **End the sale of all flavored tobacco products** so Maine kids will be far less likely to start using, and keep using tobacco, including cigarettes, e-cigarettes, cigars, and chewing tobacco.

2. Significantly increase the price of all tobacco products , which is proven to be one of the most effec tive policy tools for preventing youth initiation and incentivizing tobacco users to seek treatment.[i]

3. **Fully fund Maine's tobacco prevention and treatment program** at the U.S. Centers for Disease Control and Prevention (U.S. CDC) recommended level of \$15.9 million per year for Maine.[ii]

AAP's Technical Assistance - Support for Pediatric Providers

You can reach out at any time to <u>screening@aap.org</u> to request TA - a group of 10 physicians are available through the Screening Technical Assistance & Resource Center (<u>STAR Center</u>) - a core component of the Screening in Practices Initiative, which seeks to improve the health, wellness, and development of children through practice and system-based interventions to increase rates of early childhood screening, counseling, referral, and follow-up for developmental milestones, maternal depression, and social determinants of health.

Developmental Surveillance Training for Pediatric Clinicians/Practices

This free training, developed with support from the CDC includes a ready-to-use <u>PowerPoint</u> <u>presentation</u>, <u>facilitator script</u>, and <u>case study</u>. The training can be facilitated by providers or staff in various roles, and is specifically designed to "spark" discussion and reflection. Facilitators can anticipate the training to last approximately 15-30 minutes. Content in the training is grounded in the recently published AAP clinical report, "*Promoting Optimal Development: Identifying Infants and Young Children With Developmental Disorders Through Developmental Surveillance and Screening*."
